

The Cause of Synchronicity: Harnessing the Mind-Matter Connection (January 2003)

Author: (Prof.) E. Macer-Story, B.S., M.F.A.

Abstract--As C.G. Jung observed, there is an "a causal" in the electromagnetic continuum effect termed "synchronicity" where two or more events seemingly generated by separate linear causes form a simultaneous pattern of resemblance. This paper presents the finding that the type of event configuration observed by C.G. Jung is not "a causal" but involves the action of a non-electromagnetic continuum termed by this author in other published papers the "fluidice matrix". This "fluidice matrix" is a structuring pattern of configurational energy which transduces event structure into the electromagnetic binary sequence. Obviously, this structuring also involves the action of mind upon matter. It has been found that certain material structurings are more receptive to the fluidice matrix transduction process. In general, these are situations of forced or concomitant synergy which induce the necessity for overt, material coherence. Or these are situations of catalysis such as combustion. Thus, the investigation of "enhancement devices" for this transduction process should be conducted independently of such elaborations as "in depth psychology" and as a literal probing of exact mind/matter transactions which happen when the mind or self-organizing logos must grab onto several processes which are happening simultaneously. This logos energy or "fluidice matrix" should be treated as a form of live force/substance additional to known electromagnetic mass.

Index Terms—transduction, catalysis, non-local, synergy.

I. INTRODUCTION

In previous papers^[1] a system for understanding and coding non-local transduction of information has been proposed. This, of course, is not a mathematical system per se. It is a system of physics potentially related to engineering. In moving this system from theoretical to practical application,

the literal, non-linear simultaneous triggering of events should be considered.

One of the most interesting facets of the phenomenon of "synchronicity" or the simultaneous occurrence of four dimensional events which are products of separate linear causality but are symbolically or conceptually connected, is the physical nature of the symbolic event. It is acknowledged that this phenomenon, originally described by psychologist Dr. C.G. Jung, involves some form of non-local perception. A variety of systems, including quantum and deBroglie "mind pilot wave" models, and zero point energy algebra, have been suggested as theoretical models which account for observed esp/pk, and precognitive events.

Let us consider three versions of these theoretical models which are openly available in specialized publication. These are quantum entanglement, the "world crystal" and the "world crystal" enhanced by mind and/or time fields.

"Entanglement is unique to quantum mechanics in that, and involves a relationship (a "superposition of states") between the possible quantum states of two entities such that when the possible states of one entity collapse to a single state as a result of suddenly imposed boundary conditions, a similar and related collapse occurs in the possible states of the entangled entity no matter where or how far away the entangled entity is located. The most common form is the polarization of photons. Polarization is essentially a condition in which the properties of photons are direction dependent, a condition that can be achieved by passing light through appropriate media. Bouwmeester et al (Univ. of Innsbruck,) now report an experimental demonstration of quantum teleportation involving an initial photon carrying a polarization that is transferred to one of a pair of entangled photons, with the polarization-acquiring photon an arbitrary distance from the initial one. The authors suggest quantum teleportation will be a critical ingredient for quantum computation networks."^[2] It should be noted in context of subsequent discussion that the entire conception of "entanglement" is four dimensional and binary. Even in the case of a quantum computer (qbits) located at the nucleus of the atom, the discussion is mechanical manipulation of mass structure from within a four dimensional

manifold. When non-local effects occur simultaneously in the “entanglement” model, these effects are thought to be due to the spacetime separated particles having been in the same area of spacetime or that they will be in the same area of spacetime, four-dimensionally conceived. The “fluidice matrix” which will be discussed is separate from the limitations of the binary, electromagnetic mass continuum. Thus, causality is not absolutely dependent on relative spacetime relationships.

Let us try to summarize some of the highlights described in this book. After a resume of the basic field theoretic tools, Part I laid the background for a disorder field theory of ensembles of line-like objects. The statistical mechanics of such objects was shown to be equivalent to the statistical mechanics of a single scalar field which, in this context, was called a *disorder field*. In Parts II and III such fields were used to develop the statistical mechanics of ensembles of vortex and defect lines in superfluids and solids. In the condensed, ordered phase, the quantitative contribution of such lines to the equations of state is very small since they are practically frozen out, and the disorder field has a zero expectation value. Nevertheless, at a certain temperature the lines proliferate due to an excess of their configurational entropy, thereby destroying the order of the system. This is signalled by a non-vanishing expectation values of the disorder fields.

Note here in context of subsequent discussion that the Klienert “world crystal” supposes a “scalar” field which is called a “disorder” field and acts in addition to the electromagnetic mass structure to link lattices of matter by use of higher order gauge field mechanics. Concepts involving the “disruptive” quality of synchronous information signals will be discussed with reference to the “fluidice matrix” model. However, this “scalar” ordering of disorder fields in the “world crystal” model is different from the “fluidice matrix” concept since it is in essence a master ordering of the **exterior** atomic structuring, envisioned as a complex lattice arrangement.

The “fluidice matrix” which will be discussed is not the scalar extension of the four dimensional ordering of electromagnetic mass structure. Rather, there is an **interior** transduction mechanism within the linked nuclei of the atomic structure which serves to enact the patterning of the fluidice matrix, which is a continuum actually separate from the four dimensional electromagnetic timespace and a simultaneous higher dimensional configuration. This transduction may utilize somewhat the qbit binary “computer” possibilities within the atomic nucleus but is yet separate also from the electromagnetic qbits, pushing upon them.

The controversial theories of Internet Physicist Dr. Jack Sarfatti are heavily influenced by a number of neo-Newtonian physicists, including Hagan Klienert, John Archibald Wheeler and Albert Einstein. He asserts that the originality of certain of his formulations lies in the application of “scalar” and

“wormhole” theories only in very small areas of timespace, as follows in a brief cutting from an Internet posting:

The “fluidice matrix” model presented in this paper agrees with the perception of Dr. Sarfatti that there is a “mind pilot field” with a reciprocal relationship to electromagnetic mass, and yet differs from the stated model of mind directly gripping matter. The problem with the Sarfatti model is the “vacuum propeller” concept. Here we see a version of the outmoded idea of “ether wind”.

In the “fluidice matrix” model there is an “inner ether” entering into mass structure via the nucleus of the atom, as previously discussed in this paper with reference to the qbit formulations of modern quantum mechanics. The “fluidice matrix” is a recording and transducing force/substance which is not sentient itself but is self-organizing in response to logi and intelligences as well as to the shifting electromagnetic mass structure. The Mind fields operate via the fluidice matrix and not directly upon matter in the kinetic sense..

PROBLEM

The standard quantum qbit model, the H. Klienert “world crystal” and the J. Sarfatti “vacuum propeller” theoretical models serve to divide an electromagnetic absolute continuum into more subtle gradations of force which are basically polar or binary in conception. Even the “zero point” or “wormhole” cited by Sarfatti and others is simply a micro area of timespace which is a pivot of intersection between virtual and 4-d timespace event cones^v[5]. It has been noted by critics of the “zero point energy” theories^{vi}[6] that no actual working devices have been put forward which vindicate the zero point energy theories in any practical way.

It seems that this lack of practical use of the ZPE theories may indicate that some component of these theories is missing

which transmits kinetic force non-locally. Even on the more subtle chemical and/or neural level, the binary (polar) electromagnetic structure is a kinetic structure. All of our notions of gravitation involve the kinetic motion and transformation of mass structure. Even the quantum theory pre-supposes orbital energy levels of the atom and electron which are kinetic in concept.

Obviously, this is because the world as we experience it transactionally is kinetic. One must expect some sort of force ($F=ma$) is required in order to move from one event point to another. This is true both in the strictly Newtonian linear model and the quantum orbital model. Whether the orbitals are envisioned as "little electron planets orbiting a nuclear sun" or adjacent values in a spectrum which merges orbital and nuclear relationship, yet the conceptual model is basically kinetic and therefore spatial in the three dimensional sense.

The non-local transaction is conceptualized as occurring between two or more distinct event points and therefore the mystery is: **How can kinetic force ie. Information which changes a three dimensional configuration be transmitted without using the linear time sequence of molecules as linked dominos pushing sequentially the event into a state of change or transformation?**

Thus, systems involving the existence of a "superluminal" kinetic force have been devised. In these systems, the energy is kinetic but is somehow moving faster or slower than light. This does not make technical sense though it is a well-intentioned and admirable effort to deal scientifically with the observed phenomena of esp/pk and precognition. The problem is simply that since atomic mass structure is quantized according to the electron and/or photon, any action of kinetic energy with a different "key signature" would rupture mass structure as in a nuclear explosion.

Since such explosions do not regularly occur as the result of esp/pk and precognitive dreaming, it can be reasonably supposed that whatever causes these phenomena is not disruptive of the quantized orbital signature. Somehow non-linear information disruptive of the expected linear flow has reached the neural processing of the brain/mind system without rupturing the larger molecular structure.

PROPOSED SOLUTION:

However, there is an important non-local kinetic action which approaches this disruptive quality. This is the phenomenon of synchronicity. Dr. C. G. Jung termed synchronicity an "a causal connecting principle" but in the case of significant coincidences which carry a definite message, this label of "a causal" is very doubtful. The events have a cause which is the message which links these events in cognition. Where is the intentionality of this message located?

I suggest that the origin of what we call "synchronicity" lies in the "fluidice matrix", as previously notated in theoretical form.

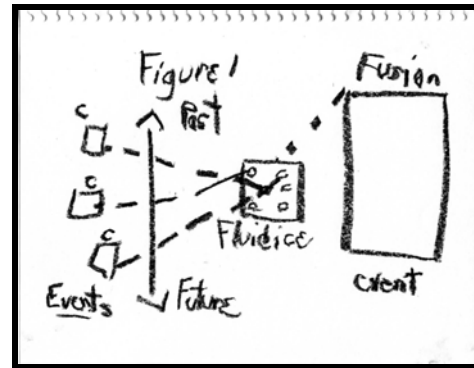
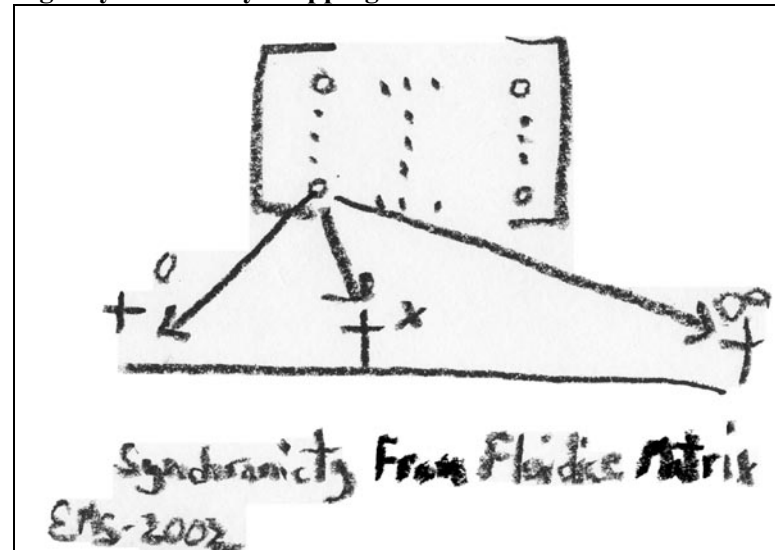


Fig.1 non-local effects from atomic fission/ fusion via fluidice matrix transduction^{vii} [7]

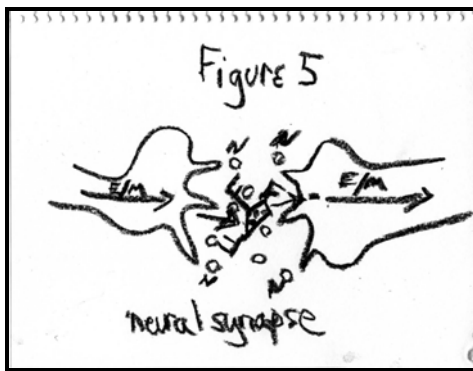
An event configuration within this matrix can map onto several different timespace locations simultaneously or in a manner separated by apparent linear, electromagnetic timespace.

How does it happen then that several entire physical, four dimensional events are thus instantaneously "popped out" into the electromagnetic continuum?

It has previously been theorized ^{viii} [8] that the traction fluidice transduction takes place within the nuclei of the linked atoms and is thus actualized within molecular mass structure in a way which is not dependent on linear molecular resonance and/or kinetic collision.

In order for this process, which is actually observed in instances of synchronicity and not simply inferred by interpretation, to occur there must be an additional kinetic energy transfer unit within electromagnetic structure as well as the additional “fluidice matrix” transmitting or “pushing into shape” events non-locally.

Some literal [force/substance] within atomic structure takes and transmits the dynamic imprint from a patterning energy which lies outside the electromagnetic continuum, creating a measurable event.. This same transduction [force/substance] takes and transmits the dynamic signals of spontaneous electromagnetic signaling into a pattern which is recorded as an event configuration in the fluidice matrix outside electromagnetic timespace.

In systems of yoga, which involves the material action of subtle energy^x[10] within organic structure, the process of imprint and patterning from/to the subtle dimensions^{xi}[11] is accomplished by the activation of “pranic” energy within the organic system. “Energy meridians” and “chackra centers” are the transduction locations visualized by traditional yoga and Chinese medicine systems. These locations are areas of the organic body where the patterning energies can, (according to tradition) most easily enter the electrochemical functioning of the body.

Yet in cases of spontaneous healing,^{xiii}[12]there is an immediate transformation of specific areas of the body which though the process may be catalytically mediated by the chackra system does not depend on any exact three dimensional congruence of location. This effect may be understood as coming from within the linked organic nuclei of the areas actually healed. Yet it is the claim of all legitimate healers that: “Not everyone can be healed”. Sometimes the process of healing by subtle energy means works and sometimes it does not work. The causality is not wholly linear, like pulling a switch. Such is an observed fact.^{xiii}[13] Why is this? Successful “psychic healing” must have some cause beyond simple emotional or ethical issues. If one looks at the fluidice matrix mapping model, a reasonable representation of this contingency emerges. If the synchronous pattern within the subtle matrix is oriented toward “health”as an integrated mind/body function, the restoration of simple physical function in an afflicted person may not benefit that person’s complete physical and mental functioning. This perspective

requires a shift from a strictly material idea of “health” to a view of the subtle energy body and actual context of the person as including but not limited to material, four dimensional functioning. If restored to material function, might the afflicted individual be harmful to self or others? Or might the time be wrong for a healing? Is the faith healer passing hands over the individual at the wrong cosmic cue? If one assumes that the patterning energy must first enter the “fluidice matrix” before transmitting the health pattern to the individual then the clear possibility emerges that the pattern may not imprint outward from the matrix process in the same form as intended by the healer.

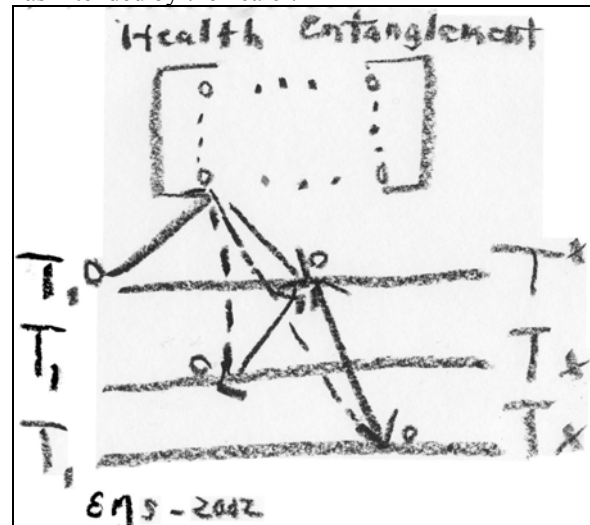


Fig.4:Entanglement of willed process with Other willed logi on parallel timelines

The pattern is contingent because it is inextricably linked with other process patterns not intended or under control of a single individual or single group intention. A fusion of destinies is the lens through which the individual concept must pass whilst becoming palpable in the four dimensional sense.

Here there is a parallel with the recognition of cyberspace as attached to certain electromagnetic arrangements of components in a computer or other electronic communications instrument. The hardware/ software combination is four dimensional and limited to those dimensions. Yet the non-local cyberspace capacity is dependent for coherent material use on the appropriate receptor/transduction arrangement. Sometimes the hardware/software system cannot adequately transduce the signal from cyberspace. Or sometimes the hardware/software seems to repair itself and learn from use.

There are a variety of persons who claim to receive spirit communications by leaving the computer active with a text function open and running.^{xiv}[14] So also in the instance of these naive experiments with non-local perception and cyberspace we see the idea of an “additional component” entering the mix. This added factor is the intelligence or “life” of the self-organizing logos, but life on the level of subtle energy which may or may-not have a material body as part of the identity matrix.

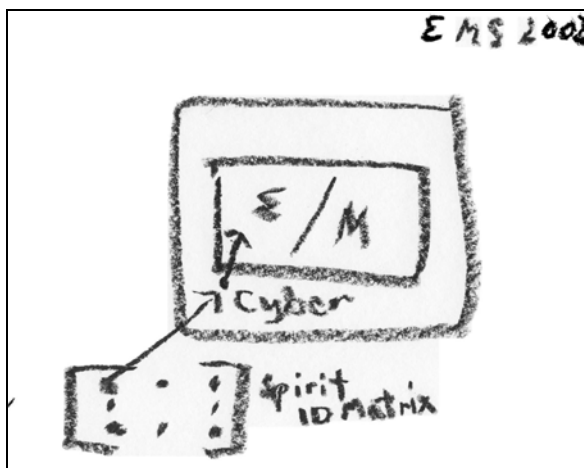


Fig 5: cyberspace receiving spirit communications

Therefore, an identity matrix may rove from receptor system to receptor system in order to “live” four dimensionally and communicate some message. It is striking that rogue computer programs are called “viruses” and that viruses actually are life forms with a distinctive structure which can be semi-crystalline in nature. Dr. John Lilly, in his research into communication between animals and humans ^{xv}[15]also claimed there was a non-organic life form he called SSI or “Solid State Intelligence” which was interrupting a variety of human events, sometimes destructively.

Ironically, this writer experienced a synchronous event whereby a virus sent by email from an associate’s computer an article on the work of John Lilly which describes Lilly’s concept of the SSI virus. The person whose computer was raided is not a scientist or technical writer with numerous files similar to the one selected by the virus.

On one level, this is simply an amusing synchronicity. But was it really “synchronicity” in the a-causal sense? Did some information system “match” between a verbal description of “Solid State Intelligence” in English in the Word file and the self-organizing intrusion of the executable virus itself which, as it evolved, turned out to be the “Christmas” virus ? At first this seems possible until one realizes that the Word file description is in alphabetic language and the “virus” is a renegade program in non-alphabetic code.

Once again, it is necessary to invoke some reference from outside the process which contains the configurational “meaning” of virus as destructive micro-intelligence in order to describe the selection of the SSI file for emailing to this particular writer, who already had contemplated the idea of a living, non-organic nano-intelligence.

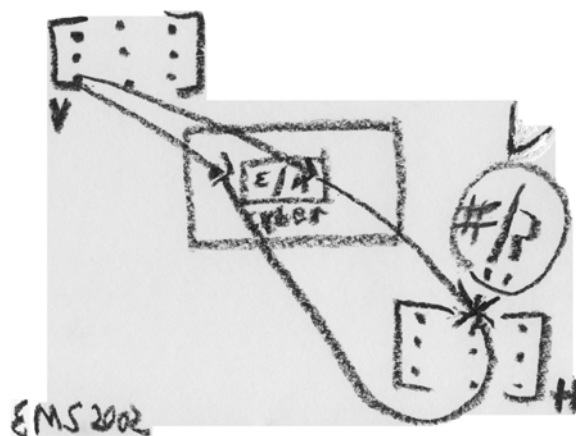
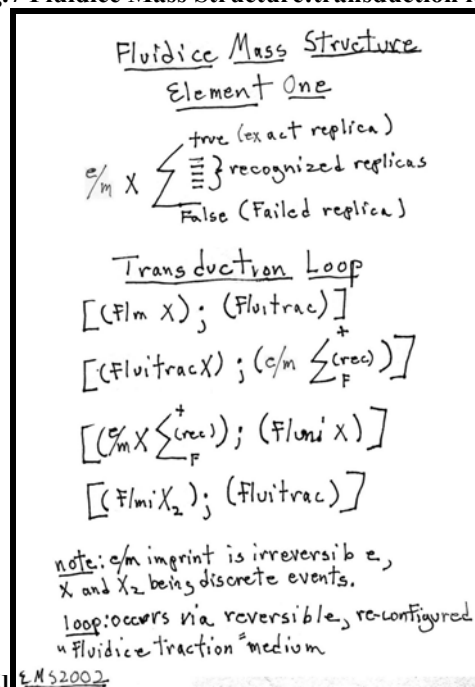


Fig.6: virus selecting “virus” as manipulated from fluidice matrix to knowing receptor who conceptualizes “virus”

Philosophical speculation aside, the key to discussing and deliberately utilizing non-local effects mediated by the fluidice matrix is the receptor system in the electromagnetic continuum. The fluidice traction transduction energy in the atomic nuclei must be able to be malleable to the “live energies” which carry self-organizing event/idea constructs to and from the recording matrix. Within the fluidice matrix, the coded electromagnetic event may be simply entered or it may be adjusted and re-fed back into the electromagnetic four dimensional arena in a variety of timespace areas simultaneous with the non-temporal matrix.

In ancient Hindu systems, these were termed the “devas” who mediated between human beings and the demi-gods and demons, occasionally also between human beings and the unknowable divine matrix. There is a clear concept in this system of thought that events and conversations extending beyond the four dimensional electromagnetic continuum require an energy courier, a translator, if you will, from one type of intelligent data organization into another.

Also, the systems of Renaissance and medieval sorcery practiced by Giordano Bruno and other hermetic adepts require a “link” with a live intelligence in the subtle dimensions in order to accomplish the desired magical transformations. Clearly, it has been observed in a variety of traditional shamanic contexts that a living, intelligent link is necessary to accomplish non-local effects deliberately. It should be obvious that this sorcery courier link is not fully limited by any material machines which may be devised because the courier logos is not itself wholly electromagnetic. The “devas” are intelligent life forms with both subtle dimensions and electromagnetic potential. Thus, this energy is a living catalyst.

However, it has been observed that candle flames in wax or tallow context with a cloth wick, in the process of combustion often signal by smoking, elongation or change of color that a “conjunction” has been successful and that a subtle spirit link or guide is present.

During combustion, molecular structure is rapidly changing form. So action of subtle energies is more apparent within a fast flux of four dimensional structure. Instances of spontaneous combustion of people^{xvii}[17] and other objects with an organic or polymer construction may be due to ignition by subtle energy flux of the “traction fluidice” which causes molecular stress and release of heat.

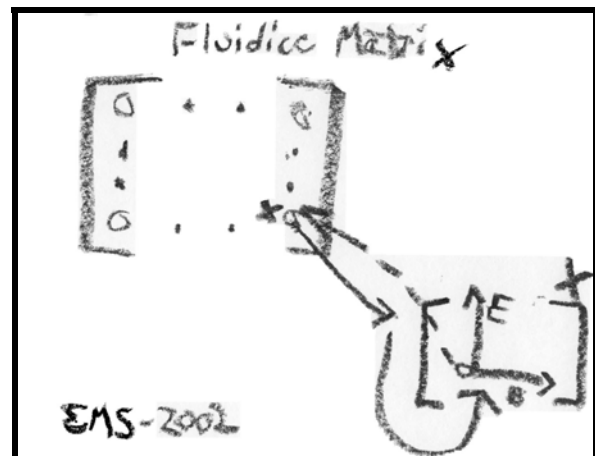
It should be commented here that certain Tibetan monks^{xviii}[18]are reputed to be able to raise and lower body temperature at will, thus being able to dry their wet clothes in a cold climate. A classic Western “supernatural” phenomenon is the cold wind or “chill” associated with ghosts .The reason that these subtle structuring events which cause a shift in

temperature are not regularly noticed directly is that combustion and rapid neural electromagnetic flux provide a condition whereby the organic structure is being subjected to catalysis .If the catalysis is throughout the entire organic system rather than in one localized area of timespace, this change will not be as easily noticed.. The rapid shift of bits which occurs when a computer is processing more than one track simultaneously is a form of dynamic catalysis. The assemblage of the systems has a greater identity by synergy than each of the processes taken separately.

So it might be reasonably inferred that the artificial structuring of enhanced “fluidice matrix” reception/ action would involve enhancement within an area where organic or natural molecular/atomic structure is in a state of rapid flux and/or system synergy. On the human body, this location would be at the back of the neck, along the spinal column and within the cerebrospinal fluid which surrounds the brain. Key associated locations at the surface of the skin would be at the top of the head, the back or front of the neck and the area of the face covering the sinus cavity.

Artificial situations of rapid synergy might be created by defining an area of rapid, parallel micro-switches in non-congruent binary flux. A “pattern” then is induced to extend from the master fluidice matrix in order to encompass and record what’s happening to the mass structure. This process is the reverse of an explosion/implosion. It is more like a cyber download and conversion process.

An ordering and inclusion of the complex data information state is happening.

In nature, this process happens when levels of altitude or depth interface suddenly or concomitantly as the living observer is falling, diving, slimbing and so on. For example: Lake Willoughby in Vermont, USA where anomalous events including alleged Lake Monsters, ufos, ghosts and sudden mysterious murders and disappearances have been experienced for generations,^{xix}[19] is also extremely deep, so deep it has never been adequately sounded. So in this naturally-occurring situation one finds a mountainous area some miles above sea level in an extremely rocky terrain and a

body of spring-fed water extending downward into a cavity in this rock, like a land-locked fiord.

In other naturally-occurring areas of non-local anomaly, there exist obvious gravitational anomalies^{xx}[20] along with bluestone and other ferro-magnetic rock and mineral deposits. It is not the purpose of this paper to probe these natural facets of the environment as there seems to be an *additional environmental factor which is causing the observed anomalies in the presence of these environmental characteristics.*

Otherwise, every area of great depth or ferro-magnetic deposit on land or sea would have gross non-local activity. This anomalous frequency of unexplained, potentially non-local activity is observed over certain areas of the Great Lakes along the U.S./ Canadian border.^{xxi}[21] as well as within sea areas such as the Bermuda Triangle southwest of the U.S. near the Caribbean. And the devil sea in the Pacific ocean south of Japan.

Here the scientific problem is both “why?” and “How can this be duplicated?” The specific natural synergy of these locations cannot be exactly replicated. But the principle of such synergy of mass process inducing a “fluidice matrix” extension into four dimensional timespace can be replicated.

Physicist Michio Kaku^{xxii}[22] has stated that he thinks it is possible that the key to detecting actual “ufo tech” if this exists as artifact of advanced extraterrestrial intelligence may lie in the specialty of nano-technology, an awareness of engineering very small effects. This possibility also applies to the concept of subtle patterning entering macro-space via the very small “traction fluidice” transduction effects within the nuclei of linked atomic structure.^{xxiii}[23]

It has been observed that spontaneous telekinetic and “ufo-like” effects occur quite frequently over or within seas or smaller bodies of water and/or involving water pipes or containers of water. In previous publications,^{xxiv}[24] this writer has described the unique structure of the water molecule as this relates to the unique expansion/contraction properties of ice. In fact, the “fluidice” name was devised originally in 1977^{xxv}[25] to describe a solid state non-electromagnetic matrix which has contraction/expansion properties similar to ice. However, the actual design of this concept has changed from the inception.

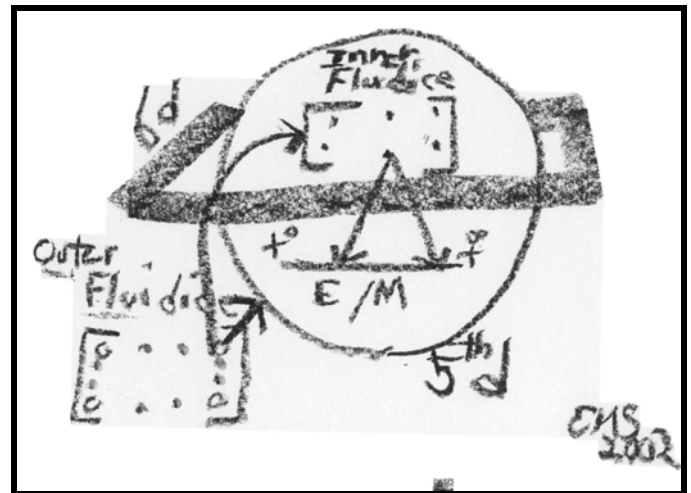
As it stands now, the “traction fluidice” is a component of the fluidice matrix present in the electromagnetic index as a facilitator; but the whole of this additional energy continuum does not have expansion/contraction characteristics because it is not wholly four dimensional but links to four dimensional spacetime by a fifth configured dimension termed by some occultists as the “astral” or “akashic” interface which codes and records the four dimensional electromagnetic activity but does not itself have four dimensional extension. An analogy is a CD which is capable of recording and reproducing video and sound but itself has no audible or visual characteristics until electromagnetic transduction takes place.

Thus, although the trigger links on the atomic level may be very small, the pattern generated by these nano-imprints may be quite large, as when a “weather shaman” is observed to call up a storm by stroking a beetle with a twig.^{xxvi}[26] Conversely, a macro structure or pattern can be set up to

“conjure” or cause nano effects such as the alteration of bits in cyberspace. The key factor, as observed, simply is that a four dimensional action should be taken to kindle a non-local four dimensional effect. This is because manipulation of the mass structure activates the “traction fluidice” for imprint of concept or symbol by mental functioning. Material mindstuff acts as the self-organizing force or logos which encloses the akashic records of the fifth dimension. This can be conceptualized as a 6th dimension coherent with both higher dimensions and the electromagnetic mass structure, represented in this model as an anchor or nugget non-locally surrounded everywhere by the fifth dimension in turn enclosed by the quasi-concentric 6th dimension of mind or will.

All of these coherent levels of living mass structure also have complex, higher dimensional correspondences, sometimes in the form of parallel universes or continua. However, this paper is limited to a description of the six dimensions most closely involved with basic mass and event structure.

Fig.10: 6 dimensional model



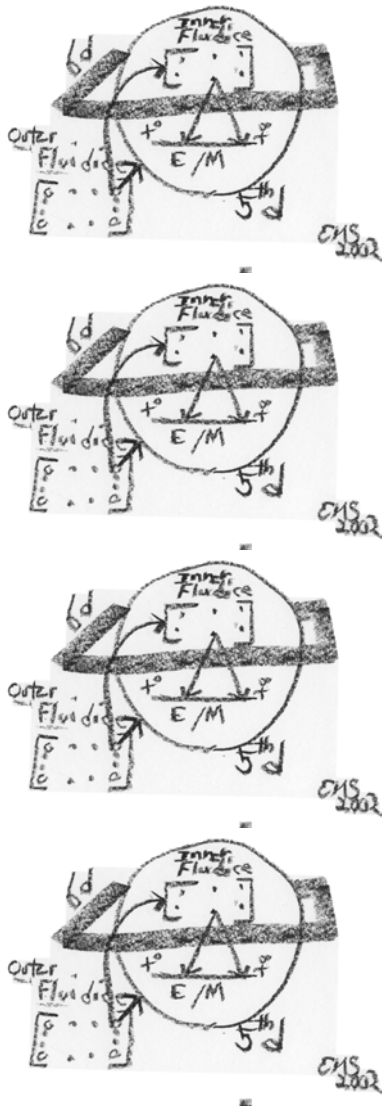
Occult and magical systems such as those taken from the symbology of ancient Egypt, which differentiate several energy bodies, as in the “ba”, “ka” and so on are a representation of this observed or “felt” process. One feels these energy levels shift as the subtle energy is shifting within the organic tissue. People often report “My arms felt longer” or “I felt taller or shorter” when experiencing a strong influx from the subtle patterning energies of the 5th dimension into their electromagnetic neural system.

The energy patterns of individual mind or intelligence then have palpable substance in the 6th dimension but more subtle participation in dimensions which do not directly contact the 6 dimensions of electromagnetic and/or organic process. There exists a hierarchy of subtlety in the dimensional structuring which can be visualized as parallel to or beside the linked 6th dimensions which have a patterned structure.

Beyond linear and configurational time, considered as the measure of 6 dimensional change, there are other continua which have causal input into the “fluidice matrix”. There are echoes and images of these continua impressed in the fifth

dimensional akashic records. Both the akashic records and the sixth dimensional mind fields in turn have resonance in additional parallel and/or concomitant dimensions. The dynamics of this linkage is complex.

Thus, nothing is without a cause but the cause may actually follow the effect in linear time or be completely obscure or incoherent in any limited 6 dimensional sphere. How is it possible to use or harness these effects to facilitate human evolution and enlightenment?

In the 6th dimension, one of the types of individual mind is the self-organizing logos. This is also a source of synchronicity as events pull unto themselves the components necessary for the maintenance of identity and integral function. Mathematicians such as physicist Michio Kaku have theorized about these many dimensions which, in the fluidice matrix model, sit somehow beside the 6 more easily discussible continua., as enhanced mirror or lens refractions. In discussing these additional continua, the concept of rebus or cartouche is helpful, a symbolic language of words and

events which must be innovated and/or learned in common by those communicating about these concepts.

The sole innovation in notation I have made in this paper is the “fluidice matrix” itself as a separate energy/force attached to the quantized electromagnetic system. Elaborations and ramifications of this sole innovation are based on the complex synergy between the additional fluidice matrix and the electromagnetic, akashic and mind pilot field functions.

The idea of “mind fields” is not particularly new.^{xxvii}[27] But the use of the mind fields as a 6th dimension is particular to the fluidice matrix model. The innovation here is to see the logos function as a physical system which literally has roots within the linked nuclei of atomic structure and can change the mass indices and shape of that structure.

A sense of this inner atomic dynamics by means of the fluidice transduction energy might also provide some entry into a real explanation of the aerial “green ufo lights” which haunted Los Alamos labs subsequent to the nuclear experimentation there at the end of World War Two. Though the bombs which were developed there did not explode in the timespace area of Los Alamos, a subtle fluidice matrix linkage within the nuclei of the atoms which had been at the Los Alamos location might non-locally cause aurora effects in the atmosphere, and also other inexplicable non-local effects to mass structures on the timeline of the detonated micro-mass ruptured at the time of fusion/fission.^{xxviii}[28]

Self-Organization of Fluidice Matrix

*Abstract:-*In previous papers, [1]the existence of an additional energy to the electromagnetic has been described and designated as [fluidice//traction fluidice]. This living energy operates to transduce information into the electromagnetic, molecular continuum from a more topological matrix of non-local information. Images in digital photos were observed to self-organize in a way which seems symbolic of intelligent intention. [2] In order to account for events of non-local signal transmission and reception , it is necessary to accept for utilitarian purposes the existence of a "carrier" transduction continuum. In this paper a possible, accessible model for this carrier energy is outlined.

A couplet structure using "fuzzy logic" will be presented as a way to link non-local signal with the electromagnetic stress matrix. Fuzzy logic, which was designed to account for systems exercising innovative and active selection and self-organization, is particularly appropriate for describing the fluidice transduction process. However, the "matrix structure" of non-local signal transmission/transduction is alive and is responsive to both mental and emotional stimuli and patterning

11 Introduction

Previously, this necessary, non-local energy continuum [fluidice//traction fluidice] was referred to as the "fluidice matrix". The term "matrix" was used simply because this makes the formulations comprehensible to those who are familiar with matrices used in electromagnetic and materials stress gauging situations where the matrix signifies a number of co-dependent processes which are linked but evolve separately, according to individual function

So the "fluidice" input could be conceptualized as "another" unique matrix linking to the atomic/ photonic (electromagnetic) matrix via one slot in the existing, self-organized stress matrix. Yet, although such a model assists in understanding these concepts, if one closely examines this rudimentary model with "the other" continuum as one place in the multi-place process of the self-organized atomic/photonic matrix, a significant problem arises. For "the other" continuum is not within the electromagnetic structure as are the other places in this rudimentary matrix. So placing this continuum as one variable in an electromagnetic stress matrix is not valid.

The "fluidice matrix"^{xxix} pushes upon and "signals into" the electromagnetic structure but cannot by its very non-local nature be included within the linear process of electromagnetic signaling. So theoretically there must be four energy components, as named: electric, magnetic and fluidice matrix, with the fluidice energy assumed to be gravitational in some way.

Rather, the matrices of mass structure would be: electric, magnetic, live traction fluidice (impression-recording traction field linked to gravitation) and fluidice mind (the non-linear memory-recording matrix).

The concept of "fluidice mind//traction fluidice" is not exactly like the "encoder/decoder" mechanism described in the original superluminal formulations of Dr. Jack Sarfatti.because the process is not wholly electromagnetic. [3]

Rather, "fluidice mind" is a matrix of information which is completely outside the linear pulsing frequencies of electromagnetic spacetime and makes non-local signal connection only via the intermediate "traction fluidice", which is a living substance. [4]

The "live" traction fluidice is closer to the idea of "mind fields" which shape matter directly, as in certain "torsion field"^{xxx} formulations. But in the "traction fluidice" model the intermediate energy transduction substance is assumed

actually to be living in the sense that any living structure has an innate organizational logos, agenda and "time trace" both locally and within the non-local "fluidice mind" matrix. In this sense it is responsive to and generates mass density shift and gravitation.

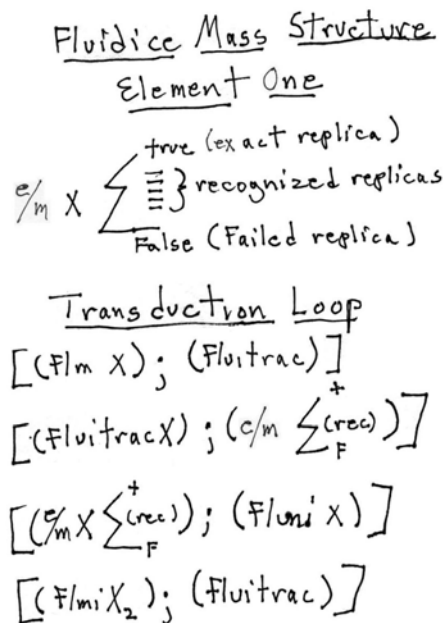
2.Problem Formulation

How become more aware of such possible non-local signals? The obvious answer is not simply to alter any small area, such as a room or cabinet, and focus upon this area. Since the brain/body system is the organic sensing mechanism for the mind, the device for enhancement of individual perception/action as far as incarnate Intelligences are concerned, should involve alteration of signal reception at the neural synapse . How can we know this process is occurring?

2.1 "Fuzzy logic" model

Systems of "fuzzy logic" will be helpful in understanding how the "traction fluidice" energy substance takes the impression of data from the "fluidice mind" matrix and transduces this impression (simultaneously, as it seems) to a variety of timespace locations which may not permit literal duplication of configured signal.

One way to represent this three-way matrix process might be as follows: The Fluidice Mind operator (fl mi) forms with Fluidice traction energy/substance a subset form (FlmiX; Fluitrac) and generates the subset

form (fluitracX; e/m) which becomes the four dimensional event (e/mX \sum ; flmi) in a loop returning to the fluidice coding matrix as (FlmiX $_2$; Fluitrac). The dynamics of this loop process are not exactly reversible because the recognition/imprint of e/m states is fuzzy, creating a self-adjusting loop between the coding matrix and material function. e/mX \sum = the range of recognition/imprint from "inexact shape" through "recognized shapes" to "exact shape". The fuzzy recognition/ imprint sequence in the loop connecting the fluidice shaping matrix with the linear electromagnetic pulse accounts also coherently for associative approximation in non-local ESP and PK communication.

2.2 K-Variable Grand Matrix

The matrix mechanism of mass structure can also be written as a static Grand Matrix when mass itself is considered to be a summation of quantized density patterns. The quantized density index (k) is originally to be found in the work of physicist Hal Puthoff [5] but the way in which Dr. Puthoff's final matrix is constructed is not a unified summation. There are several parts to his equation regarding quantized mass.

There are two, entangled elements to the unified "fluidice matrix" description of mass structure: A) the role of a quantized density index in the molecular structure (Fig 2: Variable Grand Matrix) and B) the

mechanics of action between the e/m-compatible and non-electromagnetic fluidice mind matrix continua..(Fig.1:Fluidice Mass Structure)

In the combined model,(Fig. 3: Combined Model a horizontal and vertical contingency are co-present.

Nature itself, like a multi-faceted organism, can self-organize these several matrix functions at the same time.

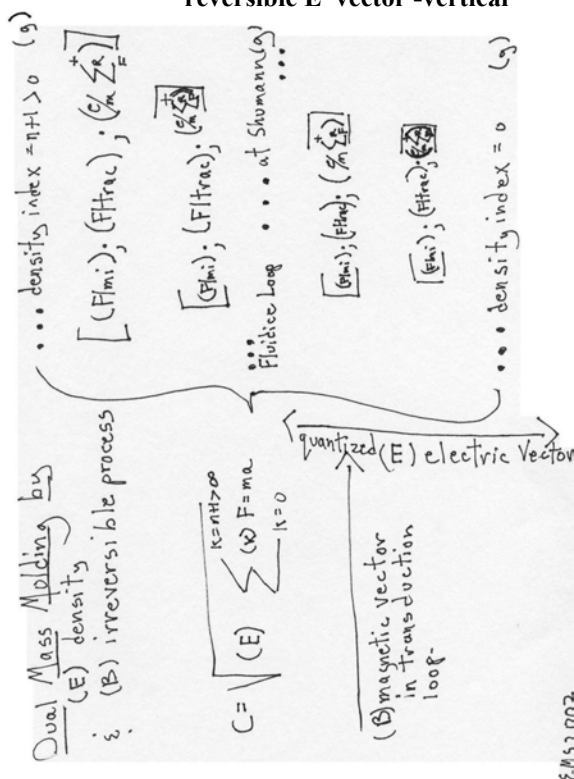
2.4 Role of Magnetic Vector

There is an interesting distinction made in certain references [6] between the E and B 3 point vectors.. The E -3 vector is said to have reversible mirror reflection properties in time & space whereas the B -3 vector does not have these exact properties.

Dr. Michael Persinger of Lurentian University in Sudbury, Ontario tested in his laboratory the effect of a weak magnetic field by using on experimental subjects an apparatus which could vector this magnetic field to any point in the brain. He was able by this method to elicit a variety of eidetic images by

causing transient, local electrical micro-seizures in the brain. Dr. Persinger's research was inspired by his theory that electromagnetic fields caused by tectonic stress in certain geographical areas produce the "ufos" and other anomalous phenomena often seen in those areas. [7]

The fact that magnetic tape recording devices in the "earth chackra" areas researched by E. Macer-Story^{xxxi}

show anomaly as well as other magnetic devices such as a simple compass indicates that the flux transduction from the unknown non-local energy fields take configurational advantage of the non-symmetric magnetic vector.

2.5 Intellective Identity Matrix

Signal transfer by an Intellective Identity matrix may form the symbolic shapes in the digital photos discussed in detail in the paper "Shaping Events::Self-Organization of Digital Photos" [8] For this reason, previous experiments have been conducted into mind over matter effects in certain geographical areas reputed to be haunted or "special"..(footnote)

As in the "fuzzy logic" mass structure diagrams, (Fig. 1) the basis of sympathetic magick is that from a small action a larger analogous material effect can be obtained. A small house may be drawn to induce the gaining of a home mortgage. A small doll is made, baptized with the name of the target, and treated or mistreated in ways which cause actual effects to the body and destiny of the person thus named.

2.5.1 esp/pk experiments

It has been noted that a practitioner on the willed-manifestation mind/mater pathway must take material action for the sympathetic material result to occur in the larger, self-organized patterning. As, by analogy, one must actually push a button to start a can opener. One cannot simply "think about" the idea of the button. Some material action must be taken to start a material process. However, the material action might be to lightly touch a square drawn on a piece of paper and marked "button" and mentally command the actual button located somewhere else to move in the mechanism. The button will then appear to move by itself but actually it has been "touched at a distance" by means of the intermediate "fluidice" inner ether transduction matrix.

As one example, the classic: "I wrote you an email at the same time you wrote me an email." involves the material action of fingers upon a keyboard and/or voice activated action; not simply the intellectual and/or emotional idea of joint messages happening at the same time. So also a cyber or artificially intelligent robotics device might be caused to become animate by directed local fluidice matrix action which is transduced non-locally..

3 Problem solution

The cause of transmutation in the "fluidice" model is not simply another, more catalytic material substance. The living substance of the "traction fluidice" which affects atomic nuclei and molecular orbital structure is interfaced with a "fluidice" live information matrix which exists outside the four dimensional restrictions. This double matrix embodies a shared intelligence or logos uniting many synergistic and self-organized actions.

The non-four dimensional information matrix may hold these events as recorded by the electromagnetic

sensory systems of the body, coded and available to the conscious identity or brain for download into cognition later, or possibly earlier than the experiment, in terms of planning the event.

4. Conclusion

It is not possible to utilize in a practical sense transduction models which are wholly electromagnetic in design. One analogy to a device which might be constructed to utilize the non-electromagnetic fluidice traction energy is the enhanced storage card in a digital camera which can be extracted and placed in another device for file transfer, printing or editing. Thus, there are two operative systems or more working in synergy. The camera, the memory card, the receptor computer, the printer or whatever other electromagnetic device is setup to decode and adjust for the traction fluidice coding. This is an analogy only. The actual fluidice matrix transduction device is different in specifics from a memory storage device, though conceptually similar. The primary difference is that fluidice traction transduction can be expected to change the "k index" of the surrounding area in the same sense that a loud vibratory sound changes the molecular structure within a limited area. Accurate computation of the dimensions of the electromagnetic area to be affected is an important part of any practical, commercial design for this device.

Action of the dual function fluidice matrix may impact both directly in the area of esp/pk research and in the area of cyber and medical research whenever very subtle and/or very small systems are being measured.. Deliberately touching material process by means of a subtly-activated cyber symbol or coding may lead to advanced use of sympathetic magick by means of an autonomic link via the living "fluidice matrix" which is independent of learned intellectual systems such as Kabalistic gematria and I Ching, considered as hexagrams and similar flow chart diagrams. Mental action using the fluidice matrix impacts directly the electromagnetic containing structure with or without intellectual recognition of intermediate systems.

But recognition of quantized, variable areas of mass density may also impact ideas of cosmology as well as mind/matter interaction. For example: the familiar Kepler's Second Law, the "Law of Areas" as regards the orbits of planetary bodies sweeping out equal areas in equal times of revolution about the parent sun might have to be revised to include the possibility of quantized k-index alterations of timespace referent to the self-organizing fluidice matrix.. Kepler's Third Law, the "Harmonic Law" which states that "the square of the orbital period of a planet is proportional to the cube of its distance from the sun" would also be perfectly true only in cases of one sun which did not naturally fluctuate in density ie jump from one coherent density level to another according to the quantized factor of the "fluidice mass" matrix (Fig.2: K-variable Grand Matrix) as described in this paper.

The possible fluctuations of quantized mass states within the matrix summation—analogue to orbital fluctuation within the atom—is beyond the scope of this paper but is an interesting topic for future research.
